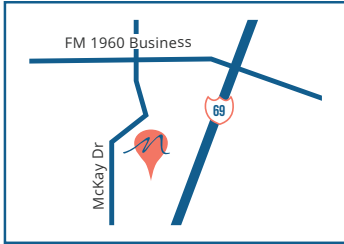

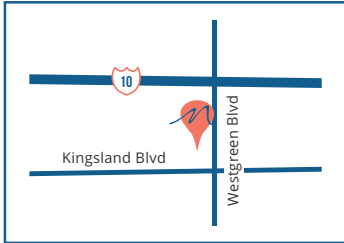

18850 S. Memorial Boulevard, Humble, TX 77338

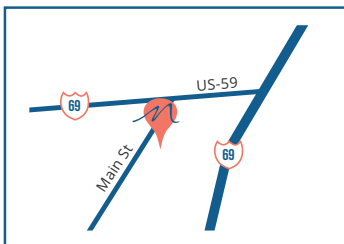

750 Westgreen Blvd., Suite 100, Katy, TX 77450

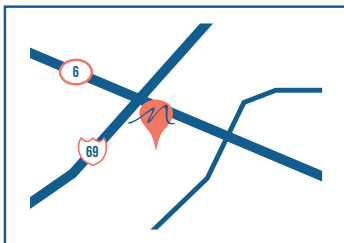

Take I-69 towards Fannin Street, Continue on Fannin Street Southeast towards Palm Street, take a right on Palm Street, located on the left into the parking lot.

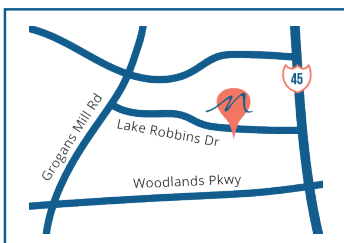


SUGAR LAND

Located in Sugar Land Town Square, Near 1-69 and Hwy 6. Texas Parking Garage - Free Parking. Garage Entrance located next to Escalante's on Texas Drive. Building Access to 15999 City Walk can be obtained by:

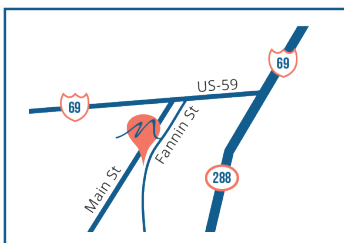
- Texas Garage 2nd floor elevator landing – follow the walkway from the garage into the 2nd floor of the building
- Texas Garage 1st floor (entry marked 15999 City Walk) – take the elevators or stairs up to the 2nd floor
- Street level from City Walk Drive (next to Turquoise Grill) – take the elevators or stairs up to the 2nd floor, building entrance is near the elevators on the 2nd floor of the Texas Garage
